The 'New President' would like to say a few words.

I recall subsequently stating that I did not want the election held before I stated what I wanted from the League and its officials. (Perhaps there was a back door out of this: after all a new job, full time post graduate studies and W.E.A.R. is stretching things a bit and Toni is away and will be no doubt less than sympathetic to my predicament!)

The last time I attended a League meeting, it seems we talked about the same matters as were listed on the agenda at this A.G.M., and that was three years ago!

- McKell Park is shrinking daily and Council is obsessed with designs and usage issues as the foundations collapse and significant erosion occurs daily.
- Sewerage, is the current "biggie", about which I know very little I must confess.
- Non water access residents talking about solutions to mooring for their tinnies. (That one sounded familiar, 1993 was the year we started "playing" with equity, safety etc]
- Muddy pathways for topsiders.
- Dogs.
- Carts, etc. etc.
- And the list goes on.

My "response" was heartfelt, simple and non-negotiable.

Like everyone attending I am in love with the Island and seek ways to make life a little easier for those who live here. Owner and tenant, waterfront owner or not, uplander or lowlander, "native" or "johnny-come-lately", it doesn't matter to me. We all have our place.

"My energies and whatever skills and talents in my possession are at your disposal" I said. "However I choose to follow rather than lead, and you'll have to decide now whether you are committed to collaborating with the community to resolve these problems and are willing to put your energies into creating solutions we can all live with. We need as a community to embrace each others' views, not necessarily agree with them, but seek after win/win solutions." (The Mooring Co-op. is a good example.)

"The League needs healthy representation, strong membership, community endorsed directions and sound implementation strategies.

Everyone would have to get involved," I said. (At this point all very lofty stuff. The medicine being delivered, I thought I was home free as every one is busy and few people want to carry the load for others!)

To my surprise **everyone** gave his or her commitment. Hence I thought I'd better make it public in the newsletter so as to close the back door as it were. I think we are all fundamentally seeking the same thing for similar reasons, and I believe every person attending that A.G.M. who committed to work for the good of the community is very special and deserving of your support.

I was buoyed by the atmosphere and pledges of support – very heady stuff – and for those who find themselves where the wise hesitate, watch out. A quick show of hands and it was all over. The beginning of a journey that leads I know not where.

1st Priority

We resolved to target the sea wall at Brooklyn and Council's neglect of the erosion problem. (How can they fine a builder in Berowra \$1500 for muddy tire tracks on the road and the "environmental damage" he caused, yet ignore wholesale erosion of "their" [that is "our"], park. I am told that over the years some 15 feet (5 m) of embankment has been lost from the original reclaimed area.

I have asked that we (the League and the Historical Society) research the historical record of this issue and that a time line be constructed of representations, investigations, studies, tests, submissions and financial expenditure, that has been lavished on this simple project to date. Council should be asked to account for grants and funds emanating from all sources that were have to been utilized in solving this problem. (Terry Dorough's tenacity and research skills invaluable in this project.)

Should be fun as well as illuminating! This material should also prove to be interesting for the community at large who raise a chuckle at "Yes Minister" and who might be shocked out of their complacency in viewing how common sense can be so corrupted by bureaucratic "nonsense" speak!

Well, there it is. Another windmill to tilt at and a small band of eager Don Quixote's. Many thanks to Ray Toman, the outgoing President, and his committee for keeping the flame burning and passing the baton. He can be especially proud of this newsletter as it is first class and has been a great innovation in his presidency.

NEWS ITEMS

McKell Park Update

Following receipt of the State of the Environment Report the League will write to Council expressing your concerns at the waste of time and money on a simple task of building a sea wall to stop erosion. Consideration is being given to dipping into the war chest and taking Council to the Land and Environment Court over the gross sediment erosion into the waterway they purportedly protect on our behalf.

We demand that work commence immediately i.e. BA/DA, on the wall at least.

There is enough E.I.S. data available now to construct a wall out of copies of studies, consultant's reports, DCP's, LEP's, management plan's, resident's proposals, parking surveys etc and still not one stone has been put in place!

We are more interested in controlling foreshore erosion than the location of tourist rotundas and planter boxes. First things first surely, "without prejudice" as to the other works yet to be finalised.

Let's stop the disappearance of our foreshore!

Waterfront Environment Action Reform [WEAR]

The general manager Lands N.S.W. Mr Graham Harding addressed a public meeting at Mooney Workers Club on 15th May and affirmed the power of his dept. to levy "wet berthing fees of \$300 per boat on crown lands on Dangar Is and at Brooklyn.

IF YOU DO NOT PAY THIS LEVY NOW, YOU WILL BE REQUIRED TO DO SO ON RE-VALUATION.

If you are a member of the mooring co-operative the dept. can levy them too! You may be facing a total charge in future of \$600.00 p.a. to access the island.

The meeting passed [unanimously] a motion calling for the cancellation of this discriminatory and unfair charge on water access only residents. 100 community members, nominated representatives, mooring co-op reps, ratepayer groups from all over the Hawkesbury were present. Notably neither the Labour member for Gosford nor the Liberal member for Ku Ring- Gai attended, and a motion of censure was carried. Stephen O'Doherty however has submitted a case to the Ombudsmen's Office involving 10 separate examples of the Depts. miss-management, for


impartial investigation.

DANGAR ISLAND BOWLING CLUB

The patronage of the Club has seen a significant increase now that we are fully licenced and this has encouraged us to provide some new services to members. In addition to our popular Friday Night Dinners prepared by Chef Sari, the Club now hosts a Saturday Night Bistro where members and their guests can enjoy an economically priced meal. The Bistro is opened from 5.30pm to 7.30pm, starters such as



lasagne and salad, curries, Thai meatballs and noodles are \$7.95 and a range of Desserts including baked cheesecake, strudel and bread and butter custard are available for \$3.50. Thanks to the work of the Dangar Island Bush Regeneration Group the Club has been able to purchase a large number of native plants and will shortly commence developing native gardens around the Club and Green. The Dangar Island Bush Regeneration Group

The May Festival of native plants was utilised by many residents to buy the indigenous plants of the Island, and find out how to eradicate their garden weeds. If anyone would like more information or a copy of the booklet 'Australian Plants of Dangar Island for your garden', please contact our group. We live in such a unique river environment that it is important to understand what is around us, and the impact humans have on it. We are also compiling a 'Fauna Study' of the Island. Our group would like the assistance of any residents who would like to become involved. The type of information we are seeking includes: Birds: Type or appearance, locality and weather they nest on the Island. Or are

they migratory.

Possums: Type or appearance, locality and habitat.

Lizards: Type or appearance, locality and habitat.

Snakes, marsupials, insects, ants, frogs and toads: Type or appearance, locality and habitat.

If anyone has information on previous studies, a copy would be very helpful to make comparisons over the course of

Children are very welcome to participate by descriptions of fauna via colour,

sounds, shapes, time and place either by text or drawing, or both. Further research can be done either at school or with the family.

The study will be done over a number of months to cover seasons, and clearly will take time to collate.

It is very important not to disturb the Fauna or their habitat but just to observe and describe. Maybe there are animals you noticed when you first came to the Island, that are not here anymore. There is also an ongoing study of Flora on the Island so we would like to know if there are plants not listed in the booklet.

The "Access" Committee Report

This committee feels that the D. I. League can only handle <u>one</u> major objective at a time and is happy for the current major objective to be the <u>reinstatement of the seawall at Brooklyn.</u>

Other possible objectives identified by this committee are as follows:

- Improvement to the pontoon at the D.I. Public Wharf.
- Improvement to the stair access at Brookin Railway Station.

Points 1. and 2. are major objectives, requiring a lot of input.

- 3. D. I. South Beach erosion
- Sealed and gravelled roadways on Işland in certain places
- Stormwater gutters to be re-lined with stone.

Points 3.4. and 5. Are "environmental" objectives requiring liaison with Hornsby Council and the Dangar Island Bushcare group.

Signage – public toilets, this committee does not like the idea of more council signs on the island and suggests the possibility of a map in the "weathershed" with indications of the features of the Island (including the location of the public toilets). Plus the native flora and fauna on the island – Drawings – colours.

Anyway the group is concentrating on the seawall problem. Discussion about any of the above topics is welcomed.

Dog Control on Dangar Island

Unfortunately there have been reported cases of innocent pedestrians being confronted by UNLEASHED dogs. It is becoming evident that there is an uncaring attitude regarding dogs roaming the Island.

This has health and safety implications, particularly regarding children in the playground. Residents are reminded of the Hornsby Council Regulations relevant to the keeping of dogs: These regulations do apply to Dangar Island.

- We are required to pick up our dog's droppings in any public place.
 Please remember they are obnoxious, offensive and dangerous to human health
- Dogs must be kept clear of children's playground equipment (10 metres), and places like the General Store.
- Any dog not controlled by a leash, is considered a roaming dog, and is at risk of seizure by the Council Animal Control Officers.

We are looking for some genuine goodwill on this issue, and suggestions to improve the situation would be appreciated. It would be awful to have to fence the children's playground.

- 'No-Confidence' petition about the HCS
- 2. Withholding 'Rates' and paying for the wall that way.
- 3. Approaching the Local Government Minister and complaining.
- Instigating ourselves a 'Work for the Dole' project with the Feds.

Frankly any amount of talking or writing just does not get through. They seem to be more interested in historical trees than Ratepayer needs. Incidentally, do you know if any money is being set aside in next year's HSC budget for the sea-wall? If not, the intentions of HSC becomes indisputable and visible to all of us. Eddie of Dang.

Clearly we all share your frustration, and you make some strong points there. Too be honest, I don't know the answer to the budget question. Not too sure about the legality of one or two of your suggestions either. However, perhaps we should invite the HSC Mayor to the June 26th League meeting. For myself I believe the HSC should advise Islanders precisely what is proposed, and exactly the timetable. If that appears unsatisfactory, Islanders can decide what should be done next. He could take in a little Island sightseeing during the visit. and share some of our 'pre-meeting' hospitality.
