## New League President

What ever has happened in the past, what ever anybody has said about anybody else, we all want to live here together and trusting the best in each other is the only way to do it. Next time you see a poster announcing a League meeting, come along. You never know, there might be some good gossip. \*\*



#### FROM THE PAST . . .

Minutes from the September 1997 League meeting reveal that a proposal was put for a community buggy for hill-dwellers. The proposal was narrowly defeated as opposing members feared it would sanction a lot more vehicles, which was viewed as undesirable. It was also stated that the prohibitive cost of the Council ute had prompted the proposal.

Results from a survey taken in May 97 also reveal that dedicated car parking at Brooklyn was felt to be very important to Islanders [86%] as an issue which needed to be addressed. 40% of residents felt that a sea wall at McKell Park was important! Guidelines for future sewerage systems was given a 43% rating. 'Improvements' to Island amenities, particularly visitorrelated were given a majority 'HELL NO' rating.

#### Membership fees

Terry D raised the issue of membership fees. There had been a suggestion that there should automatic membership for all residents/ratepayers and that membership fees be abolished.

Ron B felt we should not do away with membership fees as paid membership was a visible commitment and would carry more recognition with Council. There was always the risk that without committed membership, consultation between the League and Council could be undermined by minorities. Ron also proposes regular newsletters - membership fees would help to cover administrative costs.

Following a vote by those in attendance it was decided to retain membership fees.

Alison McKewen asked if the league was Incorporated and about the legal liabilities of Associations. A sub-committee (C Phillips, T Dorrough, P Gurney) was formed to look at the Articles of Memorandum of Association. (action Peter G to investigate and bring information to the next meeting).

#### Playgound Equipment

Sarah Galvin, on behalf of Jenny Shanley, reported on the outcome of the sub-committee meeting with Council on Wednesday 4 July. It was agreed that Council would prepare a plan to be presented to the League for approval, which shows proposed amendments to playground equipment. Council also requested that the League make a proposal for the resiting of the bubbler and plinth/plaque to a new location. The fountain was originally placed in the park to commemorate town water coming to the Island. There was a suggestion there should be an item in the Mullet Mail about the fountain and the proposal to relocate it. (action Mullet Mail).

It was questioned why vehicles were driving through the park and the damage this was causing to the grounds.

There was a proposal to build a bandstand for the children and since there was also a proposal to build a verandah on the hall there was a need for the League and the Hall Committee to discuss the options.

#### Hall Committee Report

Sara G for the Hall Committee advised there was a proposal to build a verandah on the hall. Both the League and the Hall Committee need to discuss the options and canvas ideas for a design. (action hall/playground issues to go in next MM).
